**STIPULATION**

The undersigned Parties, or through their attorneys, stipulate to the following:

1. That the dispute between Petitioner BRAD WEINREB and Real Party in Interest KEN GOSSELIN regarding challenges be resolved pursuant to this stipulation.
2. That the proposed ballot designation by KEN GOSSELIN of "Constitutional Law Attorney" is to be changed to "Attorney / Court Volunteer" as the ballot designation.
