MITIGATION OF ENVIRONMENTAL CONTAMINATION FORMER LEAKING UNDERGROUND STORAGE TANKS SAN MIGUEL FIRE PROTECTION DISTRICT, 905 GILLESPIE DRIVE, SPRING VALLEY, CALIFORNIA 91977

San Miguel Fire protection Agency and it's consultant, SCS Engineers, have been advised by the County of San Diego, Department of Environmental Health (DEH), Site Assessment and Mitigation Program (SAM), that it intends to close the above-referenced unauthorized release cases under the State's Low-Threat Closure Policy. The policy states that if site conditions meet certain criteria, the associated unauthorized release case(s) may be closed.

According to the Low-Threat Closure Policy, petroleum hydrocarbon constituents in soil and groundwater that result from the unauthorized release(s) may be left in place to degrade by natural processes (collectively known as natural attenuation), if the constituent concentrations do not pose a human health risk or adversely impact the beneficial uses of surface and/or groundwater.

This notice is to advise you that documents supporting the closure of the above-referenced cases are available for public review, and that DEH is accepting public comments on the plan from June 29, 2015, through August 31, 2015. The following reports prepared by SCS provide the information supporting the proposed case closures: *Third and Fourth Quarter 2014 Groundwater Monitoring and Sampling Report and Request for Closure, San Miguel Fire Station No. 16, 905 Gillespie Drive, Spring Valley, California*, and *Additional Site Assessment, San Miguel Fire Station No. 16, 905 Gillespie Drive, Spring Valley, California.*
