RE: Shooting Range Operation at Creek Hollow Ranch

Dear Ms. Burman,

The Code Compliance Division of Planning & Development Services recently received a complaint regarding a shooting/training facility being operated at Creek Hollow Ranch. The complaint involved SIMMEC Training Solutions out of Oceanside utilizing your property for the purpose of providing paramilitary type training which includes firearm training and first responder medical training.

This type of training is classified as Major Impact Services and Utilities in Section 1350 of the San Diego County Zoning Ordinance. The Major Impact Services and Utilities use type is not allowed on your A72 zoned property without the approval and issuance of a Major Use Permit (MUP).

The County has not inspected your property and has not verified any illegal use; however, if this type of training is occurring, this correspondence serves as a Cease & Desist Order and all training must immediately stop pending the issuance of a MUP.

Penalties for violations of the San Diego County Zoning Ordinance may include the issuance of Administrative Citations up to a total of \$10,000.00; issuance of Civil Penalties up to a total of \$50,000.00 per year, per violation; referral to County Counsel to seek a Civil Injunction; or referral to the District Attorney's Office for criminal prosecution.


