[PROPOSED] JUDGMENT OF DISMISSAL A.FTER SUSTAINING OF DEMURRER TO FIRST AMENDED CROSS-COMPLAINT WITHOUT LEAVE TO AMEND; GRANTING OF SPECIAL MOTION TO STRIKE PURSUANT TO CCP 425.16

The Court, having granted the entirety of Cross-Defendants Three Brothers Taco Shop, Inc., Paris Kargar, and Zhala Tawfiq's Special Motion to Strike Pursuant to Code of Civil Procedure 3 section 425.16 of Cross-Complainants' First Amended Cross-Complaint, and having sustained Cross-Defendant Zhala Tawfiq's Demurrer without Leave to Amend to the remaining contractrelated causes of action, and having ordered that judgment of dismissal of the countersuit as to all causes of action against the above-named Cross-Defendants be entered in favor of them, enters Judgment of Dismissal according to the terms as set forth in the Court's December 22, 2017 Order: 8 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the First Amended Cross-Complaint of the above-entitled action be and, hereby is, dismissed as to Cross-Defendants dba Tres Tagueria Three Brothers Taco Shop, Inc., Paris Kargar, and Zhala Tawfiq and Cross-Complainants shall 10 take nothing as against Three Brothers Taco Shop, Inc., Paris Kargar, and Zhala Tawfiq. 11 12 IT IS HEREBY FURTHER OFDERED, ADJUDGED AND DECREED that Cross-Defendants Taco Shop, Inc., Paris Kargar, and Zhala Tawfiq are prevailing parties 13 14 as contemplated by Code of Civil Procedure section 425.16(c) and, as such, are entitled to an award of reasonable attorney's fees and costs against Cross-Complainants, jointly and severally, incurred 15 16 in defeating the cross-action.
