CROSS-COMPLAINT WITHOUT LEAVE TO AMEND; GRANTING OF SPECIAL MOTION TO STRIKE
PURSUANT TO CCP 425.16


1 The Court, having granted the entirety of Cross-Defendants Three Brothers Taco Shop, Inc.,
2 Paris Kargar, and Zhala Tawfiq's Special Motion to Strike Pursuant to Code of Civil Procedure
3 section 425.16 of Cross-Complainants' First Amended Cross-Complaint, and having sustained
4 Cross-Defendant Zhala Tawfiq's Demurrer without Leave to Amend to the remaining contract-
5 related causes of action, and having ordered that judgment of dismissal of the countersuit as to all
6 causes of action against the above-named Cross-Defendants be entered in favor of them, enters
7 **Judgment of Dismissal** according to the terms as set forth in the Court's December 22, 2017 Order:

8 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that the First Amended
9 Cross-Complaint of the above-entitled act on be and, hereby is, dismissed as to Cross-Defendants
10 ~~Three~~³ Brothers Taco Shop, Inc., ~~Paris Kargar~~^{dba Tres Taqueria}, and Zhala Tawfiq and Cross-Complainants shall
11 take nothing as against ~~Three~~³ Brothers Taco Shop, Inc., ~~Paris Kargar~~^{dba Tres Taqueria}, and Zhala Tawfiq.

12 **IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED** that Cross-
13 Defendants ~~Three~~³ Brothers Taco Shop, Inc., ~~Paris Kargar~~^{dba Tres Taqueria}, and Zhala Tawfiq are prevailing parties
14 as contemplated by Code of Civil Procedure section 425.16(c) and, as such, are entitled to an award
15 of reasonable attorney's fees and costs against Cross-Complainants, jointly and severally, incurred
16 in defeating the cross-action. Cross-Defendants are permitted to bring a request for recovery of
17 their reasonable fees and costs via a noticed motion to this Court.
