Even if a statement of decision may be required in a hearing on a petition for a Civil Harassment Restraining Order, petitioner's request for a statement of decision was untimely. (CCP 632; *Martinez v. County of Tulare* (1987) 190 Cal.App.3d 1430,1443.)

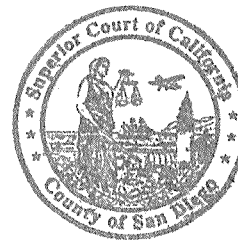
Matter before the court for Respondent's Motion for Attorney Fees. The court gives its tentative and hears argument.

Restraining order as requested is denied WITH PREJUDICCE in its entirety.
