Dear Ms. Raftery:

Your request under the California Public Records Act ("CPRA") California Government Code section ("Government Code") 6250 et seq., for our Police Department CFS reports of the above referenced incidents was forwarded to this office for review.

Government Code section 6254(f) makes files compiled by a local agency for correctional and law enforcement purposes, including arrest reports, incident reports and call for service incident reports, exempt from disclosure. Notwithstanding this general exemption, local agencies are required under Government Code section 6254(f)(1) and (2) to disclose certain information under certain circumstances.

The City has determined that some parts of responsive records are subject to the "Identity of Informants" privilege and, on the facts of this particular case, are recognized as exempt under Government Code sections 6254(k) and 6255. The City has found that disclosure of the information requested is against the public interest because there is a need to protect the process that a public entity uses to conduct its business, enforce its laws, and encourage members of the public to report suspected illegal activity without fear of reprisal, as well as a need to preserve the confidentiality of the information itself, that outweighs the need for disclosure in the interest of justice.


Further, Councilmember Kendrick's home address has been redacted pursuant to Government Code section 6254.21.
