Councilmember Ben Kalasho:

As we discussed on the phone earlier today, late last week, I was made aware of two possible FPPC violations related to your campaign. To protect the City and you from regulatory action, I ask that you correct these issues. First, on your campaign website ([www.benkalasho.com](http://www.benkalasho.com)), you include the address and phone number of City Hall on the bottom of each page. This reference to the City should be removed from your website.

Second, I was made aware that, along with traditional campaign materials, that a letter mimicking City letterhead has been included. The letterhead includes the City seal and is designed in a manner similar to the City's. As we discussed about a month ago, candidates may not use the City's seal on campaign materials, per the City's Municipal Code. To be safe, your campaign letterhead should not appear as City letterhead (i.e. remove the City seal and any address or phone numbers belonging to the City).

Thank you in advance for your cooperation in complying with this request. Please let me know if you have any questions.

SUBJECT: Continued Use of City Letterhead

Dear Mr. Kalasho:

On October 1, 2018, the City received multiple inquiries or complaints about a campaign letter on "Councilman Ben Kalasho" letterhead (emphasis mine), which included the City logo. City Council Policy A8 prohibits the use of the City seal or logo for non-official City business. Also, the mailer was sent via email, using your City email address ("From: El Cajon City Councilman <[bkalasho=cityofelcajon.us@mlsend.com](mailto:bkalasho=cityofelcajon.us@mlsend.com)> on behalf of El Cajon City Councilman <[bkalasho@cityofelcajon.us](mailto:bkalasho@cityofelcajon.us)>"), which constitutes an FPPC ethics violation, as well as possibly violating Government Code section 8314 by using public resources for unauthorized purposes. A copy of the emailed document is attached to this letter.

As a reminder, I spoke to you about a similar issue in August 2018 and on September 5, 2018, I provided a letter regarding the matter after another complaint was lodged. A copy of that letter is attached.

This letter serves as a notice to immediately cease use of the City's seal or logo in your campaigns, advocacy against other candidates, or for any other non-authorized, or non-official, business. Further, the use of the City's email account for personal reasons must cease. Any further use of the logo or seal may require the City to seek a court injunction or to take other measures.

I welcome a conversation about appropriate uses of the City logo and seal.
