1 Plaintiffs Zhala Tawfiq, Three Brothers Taco Shop, Inc. and Paris Kargar by and through
2 their counsel Jimmie Davis Parker, Esq., and Defendants Bessmon Kalasho, Jessica Kalasho, Miss
3 Middle East Beauty Pageant and Middle Eastern Chamber of Commerce, by and through their
4 counsel, David Kaufman, Esq., entered into Stipulation for Entry of Final Judgment.

5 Accordingly, in accordance with the Parties' Stipulation and Confidential Settlement
6 Agreement and Release which are incorporated by reference herein, it is hereby ORDERED,
7 ADJUDGED AND DECREED that:

8 1. The Court hereby enters final Judgment consistent with the terms set forth in the
9 Stipulation for Entry of Final Judgment and with the Confidential Settlement Agreement and Release.

10 2. Judgment is entered for the in favor of Plaintiffs Zhala Tawfiq; Three Brothers Taco
11 Shop, Inc. and Paris Kargar, collectively and equally, and against, MISS MIDDLE EAST BEAUTY
12 PAGEANT USA, INC., a California non-profit corporation; BESSMON KALASHO, an individual;
13 JESSICA KALASHO, aka JESSICA DEDDEH, an individual MIDDLE EASTERN CHAMBER OF
14 COMMERCE fka SAN DIEGO EAST COUNTY CHALDEAN AMERICAN CHAMBER OF
15 COMMERCE, jointly and severally, as follows:

- 16 a. Principal: \$300,000 collectively (or \$100,000 to each individual Plaintiff)
- 17 b. Prejudgment Interest: \$0
- 18 c. Attorney's Fees: \$0
- 19 d. Costs: \$0
- 20 e. Total: \$300,000

21 3. The Court shall retain jurisdiction of this action to enforce the provisions of the
22 Confidential Settlement Agreement and Release and for any issues related to execution of the
23 judgment.
